

Glossary

Aftercare – work with LAC from 16-21 years (or 25 if still in education)
Broker – acts as a mediator between you and services; helps you reach services
Continuing Health Care Assessment – helps health decide if some or all of your care will be funded by the NHS
CSWP – Coventry, Solihull and Warwickshire Partnership (formerly Connexions)
Employment Adviser – someone to help you consider your work options
Health Action Plan – a plan that says what help you need to stay healthy
Independence – freedom from dependence / reliance on / control by others; having sufficient means for a comfortable livelihood
Independent Travel Team – helps you travel safely and independently around Coventry
Indicative Amount – helps Adult Social Care tell you how much they think it will cost to meet your support needs
LAC – Looked After Children
Lead Professional – person who can make sure that everyone supporting you works together
Moving On Plan (S139a) – tells people about the help you need with learning beyond school
Person Centred Plan – helps everyone know what you want for your future & helps people work together to make this happen
Self Directed Assessment – helps sets out your care and support needs
Self Directed Support – helps you live your life the way you choose
Shared Lives – service provided by families to provide accommodation, support, committed and consistent relationships
Specialist Services – provided to people with a specialist or additional need over and above the general population
Support Plan – helps decide what help you want to meet your support needs
TESS – The Employment Support Service
Transition Plan – tells people what you would like to do in the future and who will help you
Universal Services – provided to everyone, regardless of need or disability



**Year 9
Age 14**

School Review
 Transition Plan completed by School & CSWP Personal Adviser; plus for those requiring support from Adult Services, Lead Professional, Employment Adviser, Travel Adviser from the Independent Travel Team. You may get help to make your Health Action Plan; and support through School Nursing.

Social Care
 Social Worker to help plan your future, review support; and arrange Individual Budget if appropriate.

Transition / School Review
 Ideas and all new actions written into Transition Plan, with support from all professionals. CSWP Personal Adviser offers advice on education, training and employment opportunities. Where appropriate an Employment Advisor from TESS will attend to offer support around employment

**Year 10
Age 15**

Health
 Discussion on supporting ongoing health needs. For those requiring support post-18, discussion with health care colleagues and referral for Continuing Health Care Assessment (Adult) as required.

Social Care
 Transitions Social Worker to assist with ensuring that support needs can be met within budget (indicative amount). Offer advice on using Individual Budgets and Direct Payments; sharing support plans with relevant parties, e.g. Adult Social Care colleagues; consider LAC and liaise with After Care, Adult Social Care and Children's Placement Team

**Year 12
Age 17**

**Year 11
Age 16**

Transitions Forum
 Offered screening assessment to assess entitlement to post-18 services. For Looked After Children (LAC), Pathway Plan completed and referral to Aftercare begins.


Transition / School Review
 Transition Plan updated; Person Centred Plan created. CSWP Personal Adviser to advise about options for the future – e.g. remaining in school until 19; and write Moving On Plan (S139a) to access support at college or training. Where appropriate an Employment Advisor from TESS will attend to offer support around employment

Social Care / Health
 Transitions Social Worker & health worker to liaise with Adult Social Care from 17½ years so that they can set up your Support Plan with agreed costings. For LAC, Pathway Plan updated.

School Review
 Transition Plan and Person Centred Plan updated. Also attended by a Travel Adviser from the Independent Travel Team if needed. CSWP Personal Adviser will have ongoing input. Where appropriate an Employment Advisor from TESS will attend to offer support around employment

Looked After Children
 If you are in a children's residential placement and expected to stay past 18, we will need to ask Ofsted for a variation and possibly refer to Shared Lives & complete Care Funding Calculator.

Notes
 All meetings should include the young person, family and all key professionals. Efforts should be made to link reviews, assessments and plans to reduce paperwork and time spent in meetings. For Looked After Children (LAC): A representative from Adult Social Care should attend the final LAC Review. If safeguarding concerns arise at any point, this will need to follow department guidelines.
